WHEREAS, there is every apprehension of breach of peace and tranquility on the day of examination in the vicinity of examination centres,

And

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examinees and other persons,

And

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid day in and around the examination centres,

NOW THEREFORE, in exercise of the power conferred by Sub Sec (1) read with sub Section(3) of Sec-144 of the Code of Criminal Procedure-1973 (2 of 1974), I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government vide Home (Police) Department Order No.-3636-PL/PB/14M-138/04 dt. 26.08.11 to act u/s-144 of the said code do hereby prohibit the assembly of five(5) or more persons within the radius of 100 (hundred) meters of the periphery of all the above mentioned examination centres within the Metropolitan area of Howrah from 08:00 hrs. to 16:00 hrs. on the day of examination, i.e. on 24.12.2023.

And all the **Photo Copying Centres** operating **within 100 (hundred) meters** from all the **examination centres** stated above **shall not be allowed** to operate **from 08:00 hrs. to 16:00 hrs.** during the examination mentioned above on the aforesaid day.

And any **loud speaker within 100 (hundred) meters** from all the examination centres stated above **shall not be allowed** to operate during the hours of examination mentioned above on the aforesaid day.

Whereas it is necessary for preventing danger, obstruction or inconvenience to the public in connection with the **New Year's Eve on 31.12.2023 and New Year's Day on 01.01.2024** it is informed by Kolkata Police Traffic Notification No TP/43 dated 28.12.2023 of Commissioner of Police Kolkata that on that particular day no goods vehicles will be allowed to enter into the jurisdiction of Kolkata Police. In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide notification no. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department, I, Shri Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah do hereby issue the following restriction orders as per the following time-schedules in the Howrah Police Commissionerate area —

Restrictions for Goods Vehicles:

Movement of all types of goods vehicles shall be prohibited to ply along various roads towards Kolkata City from 15:30 hrs on 31.12.23 to 04:30 hrs on 01.01.2024 and again from 15:30 hrs on 01.01.2024 to 00:00 hrs on 02.01.2024.

Exceptions:

- Emergency vehicles like Vehicles carrying LPG Cylinder only, Petroleum , Oil, Lubricants, Oxygen, Milk, Medicine, Vegetable or fruits etc.
- Port originated or Port related or Port bound Goods vehicles.
- Light Goods vehicles having gross vehicle weight not exceeding 1600 kg (Ex. TATA ACE, Mahindra Zeeto, Suzuki Super Carry etc).

THESE NOTIFICATIONS SHALL BE ENFORCED IN ADDITION TO THE NORMAL RESTRICTIONS ON THE DAYS, WHICH ARE NOT REPUGNANT TO THE ABOVE.
