#### ORDER

#### Memo No. 341(60)/CP

Date:- 16.03.2023

WHEREAS information has been received from credible sources that violent demonstrations are likely to take place resulting in large scale disturbance of the public tranquility and breach of the peace in the area mentioned in the schedule below (of the Shibpur Police Station) in the town of Howrah (hereinafter referred to as the said areas)

#### And

WHEREAS I, Praveen Kumar Tripathi, Commissioner of Police, Howrah being the Executive Magistrate for the Metropolitan area of Howrah, have been specially empowered by the State Government vide Home (Police) Department Order No.-3636-PL/PB/14M-138/04 dt. 26.08.11 to act under the Section 144 of the said Code of Criminal Procedure, 1973 (Act 2 of 1974)

#### And

WHEREAS in my opinion, there is sufficient ground for proceeding under the said Section for immediate prevention of disturbances of the public tranquility and breach of peace within the said area in the town of Howrah. And

Now, therefore, in exercise of the power conferred by Sub-Section (1) of section 144 of the Code of Criminal Procedure, 1973 (Act. 2 of 1974) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate for the Metropolitan area of Howrah, do hereby prohibit for the period of 60 (sixty) days from the **17<sup>th</sup> March**, **2023 to 15<sup>th</sup> May**, **2023** until further orders, any assembly of 05 (five) or more persons in procession or the carrying of any lathi or other dangerous weapons or the doing of any act which is likely to cause disturbances to the public tranquility and breach of the peace within the said area in the town of Howrah.

2)	On the East by	-	Khetro Banerjee Road, Nabin Banerjee Lane, A K Roy Chowdhury Lane and Mollapara Lane upto G T Road crossing including Kazipara Morh. Hiralal Banerjee Road, Dinu Master Lane, Mollahpara Lane upto G.T. Road Crossing (D.B. College), Danesh Mollah Lane upto G T Road crossing.
3)	On the West by	-	K. M. Banerjee Road, Circular 2 <sup>nd</sup> Bye Lane, Seikhpara, Kona Expressway upto Carry Road crossing. K. M. Banerjee Lane, Sarat Chatterjee Road upto old 58 Bus stand.
4)	On the South by	-	Tarapada Chatterjee Road, Upen Chatterjee Road upto Betaitala More.

With reference to Org No. 5698 (23)/DS Dated. 16.03.2023 of Directorate of Security, WB, 0198-Prot Dated 17.03.2023 of OSD & Under Secretary, Home & Hill Affairs Department, Government of WB and F. No. IV-11011/12/23-TS Dated 13.03.2023 of Group Captain, President's Secretariat, New Delhi, India, the following Order is made from the safety and security aspect of the Hon'ble President of India in respect of the visit of the VVIP under Howrah Police Commissionerate on 28.03.2023.

**WHEREAS,** the Hon'ble President of India will be visiting Belur Math under PS- Bally on 28.03.2023 and the dignitary will visit Birbhum district through HPC area on the same day through the following tentative routes may be used for the safe journey of the VVIP to the programme venue:

#### A. <u>When the VVIP will be visiting Belur Math:</u>

**1. Main Route** for both Onward & Return journey from 2" Hooghly Bridge to Belur Math via Carrie Road crossing, Hang Sang Crossing, Nibra Morh, Salap Crossing, '0' Point, Nivedita Toll, Bally Halt, Bally Ghat & Badamtala.

**2.** Alternative Route for both Onward & Return journey from Old Bally Bridge to Belur Math via Bally Ghat, Badamtala & Bally Khal.

#### B. When the VVIP will be visiting Birbhum District:

**1.** Alternative Route from 2" Hooghly Bridge to Maitypara via Carrie Road Crossing, Hang Sang Crossing, Nibra Morh, Salap Crossing, NH-2 & NH-6 Crossing.

**2. Alternative Route** from Maitypara to Nivedita Bridge via '79' Points, Nivedita Toll Plaza.

And

WHEREAS, the VVIP is a "Blue Book" protectee and as per protocol, for the safety and security, it is necessary to declare "No Flying Zone of Drone" within the 2 KMs periphery of the venue as well as within the 2 KMs periphery of the above noted routes on 28.03.2023 from 05:00 hrs to 18:00 hrs.

And

WHEREAS, it is felt expedient to pass certain directions to declare "No Flying Zone of Drone" to restrict the flying drone cameras and other flying items, within the 2 KMs periphery of the venue as well as within the 2 KMs periphery of the above noted routes on 28.03.2023 from 05:00 hrs to 18:00 hrs.

And

**NOW THEREFORE,** in exercise of the power conferred by Sub Sec (1) read with sub Section (3) of Sec-144 of the Code of Criminal Procedure-1973 (2 of 1974), I, Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government vide Home (Police) Department Order No.-3636-PL/PB/14M-138/04 dt. 26.08.11 to act u/s-144 of the said code do hereby declared **"No Flying Zone of Drone"** to prohibit the flying of drone cameras and other flying items within the 2 KMs periphery of the venue as well as within the 2 KMs periphery of the above noted routes on 28.03.2023 from 05:00 hr to 18:00 hrs.

# The Cell will ensure compliance of the instructions given by Hon'ble High Court which are as follows –

1) Applications shall be serially numbered and date and time of receipts is to be maintained in the register.

2) The applicant shall have to specify a rough approximate number of persons likely to participate and the route through which such rally should proceed and also the place where it will converge.

3) A level playing field shall be ensured to all organizers irrespective of the ideology they profess.

4) Steps shall be taken by the police to ensure that the register is available online.

DCP, HQ, HPC will monitor the functioning of the Cell and guide them on regular basis so that instructions are properly complied with. All OCs of the police stations are directed to act as per the instructions given by Hon'ble High Court, Calcutta. They will also inform all parties/ organisations so that applications are submitted in time and applicants are also aware of the instructions issued upon them by Hon'ble High Court, Calcutta. Zonal ACsP/ADCsP/ Divisional DCsP will guide the OCs accordingly.

And whereas, it is essential for preventing danger, obstruction or inconvenience to the public in connection with this visit I, Praveen Kumar Tripathi, *IPS*, Commissioner of Police, Howrah, in exercise of power conferred upon me u/s 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide Notification no. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department, Govt. of West Bengal in suppression of all order/orders passed in this regard do hereby order that all Goods Vehicles are barred from entry into or exit from Howrah Police Commissionerate area from 05:00 hrs to 16:00 hrs on 28<sup>th</sup> March (Tuesday), 2023.

WHEREAS, from the reports received so far, there is sufficient ground to apprehend that the terrorists or anti-social elements may seek hideouts in

the residential areas of the Police Stations, falling under metropolitan area of Howrah,

AND WHEREAS, there is every likelihood of breach of peace and disturbance of public tranquility and also there is grave danger to human life and safety and injury to public property on that account,

AND WHEREAS, it is felt necessary that some procedural safeguards should be put on tenancy or licensing process prevailing, so that terrorists or anti-social elements in the guise of tenants may not get tenancy or license for residential purpose and to cause disturbance or public tranquility or danger to human life or safety to public at large,

AND WHEREAS, it is felt expedient to cause immediate prevention of those apprehended danger and arrange for speedy remedy thereof, in the interest of public tranquility, safety of human life, prevention of injury, annoyance to persons etc.,

NOW THEREFORE, in exercise of the power conferred by sub-section (I) read with sub-section (3) of section 144 of the Code of Criminal Procedure, 1973 (2 of 1974), I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government Home (Police) Department Order No. 3636-PL/PB/14M-138/04 dt. 26.08.2011 to act under Section 144 of the Code of Criminal Procedure, 1973 (2 of 1974), do hereby order that no land-lord or owner or person whose property falls under the jurisdiction of area of any of the Police Stations under Howrah Metropolitan area shall let/sublet/lease/rent out any residential accommodation or grant lease or license to any person unless and until the said landlord/owner/person has furnished the particulars of the said tenant(s)/ license as the case may be as per the Proforma in Schedule-I to the Officer in-Charge of the Police Station concerned. And whoever having property in his possession or under his management shall also inform in writing to the Officer-in-Charge of the Police Station concerned in whose jurisdiction the premise falls about the particulars of the tenants or leasee or licensee as the case may be as per the said proforma.

This order shall come into force on and from **31**<sup>st</sup> **day of March, 2023** and remain in force for a period of 60 (sixty) days i.e., upto **29**<sup>th</sup> **day of May, 2023** unless rescinded or altered earlier.

Any person contravening this order is liable to be punished under Section 188 of the Indian Penal Code.

As the notice cannot be served individually on all concerned the order is hereby passed ex-parte. It shall be published for the information of public through Howrah Police Gazette, Official Website of Howrah City Police and by affixing copies on the notice boards of the offices of DCP, Central Division, DCP, South Division, DCP North Division, Divisional DCPs, Divisional ACPs and all Police Stations concerned and the Offices of Howrah Municipal Corporation.

WHEREAS, a large number of commercial places, network service providers and shops have come up in the Metropolitan area of Howrah as notified in this behalf, in the popular name Cyber Cafe,

AND WHEREAS, a large number of people frequently visit these Cafes to use the internet, computer network facilities available in those cyber cafes,

AND WHEREAS, there is every likelihood that the said facilities might be used by persons knowingly or intentionally to mislead the security and investigating agencies, commit offence as defined in Chapter-XI of the Information Technology Act, 2000 (21 of 2000), create panic in the public, help in anti-national activities affecting security of the state,

AND WHEREAS, it is felt expedient to cause immediate prevention of those apprehended danger and arrange for speedy remedy thereof, in the interest of public tranquility, safety of human life, prevention of injury, annoyance to persons etc.,

NOW THEREFORE, in exercise of the power conferred by subsection (I) read with sub-section (3) of section 144 of the Code of Criminal Procedure, 1973 (2 of 1974), I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government Home (Police) Department Order No. 3636-PL/PB/14M-138/04 dt. 26.08.2011 to act under Section 144 of the Code of Criminal Procedure, 1973 (2 of 1974), do hereby order, the owners of the said cyber cafes and persons having management of those cyber cafes to follow the followings in respect of those cyber cafes, viz. :-

- a) Prohibiting the use of cyber cafe by unknown person and whose identity has not been established before the owner of the cafe.
- b) Maintaining a register for identity of the visitors or users.
- c) Make an entry in the handwriting of the visitors or users maintaining name, address, telephone number and identity proof. The visitors/users shall also sign the register kept for this purpose.
- d) The identity of the visitors or users shall be established through Identity Card, Voter Card, Ration Card, Driving License, Passport and Photo Credit Card (any one of them).
- e) Activity server log should be preserved in main server and its record should be preserved for at least six months from the point of last use.
- f) If any activity of any visitors or users is of a suspicious nature, the owner of Cyber Cafe shall immediately inform the nearest Police Station.
- g) Record be maintained about the specific computer used by the visitor or user.

This order shall come into force on and from **31<sup>st</sup> day of March, 2023** and remain in force for a period of 60 (sixty) days i.e., upto **29<sup>th</sup> day of May, 2023** unless rescinded or altered earlier.

Any person contravening this order, is liable to be punished under Section 188 of the Indian Penal Code.

As the notice cannot be served individually on all concerned the order is hereby passed ex-parte. It shall be published for the information of public through press and by affixing copies on the notice boards of the offices of all Divisional D.Cs.P, all Divisional A.D.Cs.P, all Divisional A.Cs.P and all Police Stations concerned;
