#### ORDER

Memo No. 1263(48)/CP

Whereas it is necessary in the interest of public safety and convenience for the work taken up by the HRBC Authority of rehabilitation of 2<sup>nd</sup> Hooghly Bridge including replacement of stay and holding down cables and bearing, it is informed by Kolkata Police vide Notification No.TP/32 dtd.17.10.2023 by Commissioner of Police Kolkata that all types of Heavy Goods Vehicles and Medium Goods Vehicles shall be restricted to enter into the jurisdiction of Kolkata Police through 2<sup>nd</sup> Hooghly Bridge from 01.11.2023 for 08 (eight) months. In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide notification no. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department I, Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah do hereby issue the following restriction orders on the following roads.

#### **Restrictions for Vehicles:**

- 1. Movement of all types of HGVs and MGVs will be restricted towards Kolkata via 2<sup>nd</sup> Hooghly Bridge (Vidyasagar Setu) **from 01.11.2023.**
- 2. Movement of all types of Heavy Goods Vehicles and Medium

Goods Vehicles will be allowed towards Kolkata via Nivedita Setu only from 01.11.2023.

- 3. All types of Heavy Goods Vehicles and Medium Goods Vehicles will be restricted from Nibra More towards Kolkata along Kona Expressway & 2<sup>nd</sup> Hooghly Bridge from 01.11.2023.
- 4. All types of Heavy Goods Vehicles and Medium Goods Vehicles will be restricted from Kazipara Crossing towards Kolkata via 2<sup>nd</sup> Hooghly Bridge from 01.11.2023.
- 5. All types of Heavy Goods Vehicles and Medium Goods Vehicles will be restricted from Hung-Sung Crossing towards Kolkata via 2<sup>nd</sup> Hooghly Bridge from 01.11.2023.
- 6. All types of Heavy Goods Vehicles and Medium Goods Vehicles will be restricted at Kona Truck Terminal towards Kolkata along Kona Expressway & 2<sup>nd</sup> Hooghly Bridge from 01.11.2023.
- 7. All types of Heavy Goods Vehicles and Medium Goods Vehicles will be restricted at 'No Entry' point at Alampur under fly over towards 2<sup>nd</sup> Hooghly Bridge from 01.11.2023.
- 8. All types of Heavy Goods Vehicles and Medium Goods Vehicles will be restricted from Mourigram More towards Kolkata via 2<sup>nd</sup> Hooghly Bridge from 01.11.2023.
- 9. All types of Heavy Goods Vehicles and Medium Goods Vehicles will be restricted from Mondirtala towards Kolkata via 2<sup>nd</sup> Hooghly Bridge from 01.11.2023.
- 10. All types of Heavy Goods Vehicles and Medium Goods Vehicles will be restricted from Bataitala Ramp towards Kolkata via  $2^{nd}$  Hooghly Bridge from 01.11.2023.
- 11. All types of Heavy Goods Vehicles and Medium Goods Vehicles will be restricted from T.C. Motor near Salap More towards Kolkata via 2<sup>nd</sup> Hooghly Bridge from 01.11.2023.

This order shall come into force from 01.11.2023 for 08 (eight) months.

THE ABOVE REGULATION SHALL BE ENFORCED IN ADDITION TO THE NORMAL RESTRICTIONS WHICH ARE NOT REPUGNANT TO THE ABOVE.
