Memo No. 28(60)/CP, HPC

Dated: 10.01.2024. WHEREAS information has been received from credible sources that violent demonstrations are likely to take place resulting in large scale

disturbance of the public tranquility and breach of the peace in the area mentioned in the schedule below (of the Shibpur Police Station) in the town

of Howrah (hereinafter referred to as the said areas)

And

WHEREAS I, Praveen Kumar Tripathi, Commissioner of Police, Howrah being the Executive Magistrate for the Metropolitan area of Howrah, have been specially empowered by the State Government vide Home (Police) Department Order No.-3636-PL/PB/14M-138/04 dt. 26.08.11 to act under the Section 144 of the said Code of Criminal Procedure, 1973 (Act 2 of 1974)

And

WHEREAS in my opinion, there is sufficient ground for proceeding under the said Section for immediate prevention of disturbances of the public tranquility and breach of peace within the said area in the town of Howrah.

And

Now, therefore, in exercise of the power conferred by Sub-Section (1) of section 144 of the Code of Criminal Procedure, 1973 (Act. 2 of 1974) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate for the Metropolitan area of Howrah, do hereby prohibit for the period of 60 (sixty) days from the 11th January, 2024 to 10th March, 2024 until further orders, any assembly of 05 (five) or more persons in procession or the carrying of any lathi or other dangerous weapons or the doing of any act which is likely to cause disturbances to the public tranquility and breach of the peace within the said area in the town of Howrah.

The Schedule

The area within the jurisdiction of Shibpur Police Station in the town of Howrah bounded -

1) On the North by -Haradeb Bhattacharyay Road upto and including Mandirtala Bus Stand.

2) On the East by Khetro Baneriee Road, Nabin Baneriee

Lane. A K Roy Chowdhury Lane and Mollapara Lane upto G T Road crossing including Kazipara Morh. Hiralal Banerjee Road, Dinu Master Lane, Mollahpara Lane upto G.T. Road Crossing (D.B. College), Danesh Mollah

Lane upto G T Road crossing.

K. M. Banerjee Road, Circular 2nd Bye 3) On the West by

Lane, Seikhpara, Kona Expressway upto Carry Road crossing. K. M. Banerjee Lane, Sarat Chatterjee Road

upto old 58 Bus stand.

4) On the South by -Tarapada Chatterjee Road, Upen

Chatteriee Road upto Betaitala More.

All the ramps of Vidyasagar Setu on Howrah side.

Whereas for peaceful observance of **Makar Sankranti** to be celebrated on **15.01.2024** it is informed by Kolkata Police vide Traffic Notification No TP/01 dated 05.01.2024 of Commissioner of Police, Kolkata and Memo No TCR/09/2024 dated 08.01.2024 of Deputy Commissioner of Police (Traffic), Kolkata Police that on that particular day no goods vehicle will be allowed to enter into the jurisdiction of Kolkata Police. In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide notification no. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department, I, Shri Praveen Kumar Tripathi, *IPS*, Commissioner of Police, Howrah do hereby issue the following restriction orders as per the following time-schedules in the Howrah Police Commissionerate area —

Restrictions for Goods Vehicles:

Movement of all types of Goods Vehicles shall be prohibited to ply along various roads towards Kolkata City on 15.01.2024 from 03:30 hrs to 22:00 hrs.

Exceptions:

- Emergency vehicles like Vehicles carrying LPG Cylinders only, Petroleum, Oil, Lubricants, Oxygen, Milk, Medicine, Vegetable / Fruits / Fish etc.
- Goods vehicles having gross vehicle weight not exceeding 1600 kg (Ex. TATA ACE, Mahindra Zeeto, Suzuki Super Carry, etc.) shall be allowed to ply from 16.00 hrs. on 15.01.2024.

THESE NOTIFICATIONS SHALL BE ENFORCED IN ADDITION TO THE NORMAL RESTRICTIONS ON THAT DAY, WHICH ARE NOT REPUGNANT TO THE ABOVE.

WHEREAS, it is felt expedient to pass certain directions to prevent obstructions, annoyance or injury to any person employed in connection with the examination and to prevent any danger to life, safety or disturbance to the examinees and other persons,

And

WHEREAS, it is further felt expedient to arrange for speedy remedy in case of breach of peace and public tranquility on the aforesaid days in and around the examination centres,

NOW THEREFORE, in exercise of the power conferred by sub sec (1) read with sub section(3) of Sec-144 of the Code of Criminal Procedure- 1973 (2 of 1974), I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate in relation to the Metropolitan area of Howrah and being empowered so to do by the State Government vide Home (Police) Department Order No.-3636-PL/PB/14M-138/04 dt.26.08.11 to act u/s-144 of the said code do hereby prohibit the assembly of five(5) or more persons within the radius of 100 (hundred) meters of the periphery of the said examination centres (mention above) within the Metropolitan area of Howrah from 08:00 hrs to 16:00 hrs on the days of D.EI.Ed. Part-II Treoretical examination.

And all the Photo Copying Centres operating within 100 (hundred) meters from the examination centres shall not be allowed to operate from 08:00 hrs to 16:00 hrs during the hours of examination mentioned above on the aforesaid days.

And any **loud speaker within 100 (hundred) meters** from the examination centres stated above **shall not be allowed to operate from 08:00 hrs. to 16:00 hrs.** during the hours of examination mentioned above on the aforesaid days.

PUNISHMENT
