ORDER

Memo No. 814(60)/CP

Date:- 13.07.2023

WHEREAS information has been received from credible sources that violent demonstrations are likely to take place resulting in large scale disturbance of the public tranquility and breach of the peace in the area mentioned in the schedule below (of the Shibpur Police Station) in the town of Howrah (hereinafter referred to as the said areas)

And

WHEREAS I, Praveen Kumar Tripathi, Commissioner of Police, Howrah being the Executive Magistrate for the Metropolitan area of Howrah, have been specially empowered by the State Government vide Home (Police) Department Order No.-3636-PL/PB/14M-138/04 dt. 26.08.11 to act under the Section 144 of the said Code of Criminal Procedure, 1973 (Act 2 of 1974)

And

WHEREAS in my opinion, there is sufficient ground for proceeding under the said Section for immediate prevention of disturbances of the public tranquility and breach of peace within the said area in the town of Howrah.

And

Now, therefore, in exercise of the power conferred by Sub-Section (1) of section 144 of the Code of Criminal Procedure, 1973 (Act. 2 of 1974) read with the sub-section (3) of the said section, I, Praveen Kumar Tripathi, Commissioner of Police, Howrah and Executive Magistrate for the Metropolitan area of Howrah, do hereby prohibit for the period of 60 (sixty) days from the 15th July, 2023 to 12th September, 2023 until further orders, any assembly of 05 (five) or more persons in procession or the carrying of any lathi or other dangerous weapons or the doing of any act which is likely to cause disturbances to the public tranquility and breach of the peace within the said area in the town of Howrah.

Whereas for preventing danger, obstruction or inconvenience to the public in connection with observance of **Sahid Diwas** by West Bengal Pradesh Trinamool Yuba Congress Committee in front of Head Office of CESC Ltd. i.e. Victoria House, Kolkata on **21.07.2023**, it is necessary in the interest of Public safety, to impose traffic restrictions for regulating the movement of vehicles at different parts of Howrah Commissionerate area. In exercise of powers conferred upon me U/S 112(2)/115/116/117 of Motor Vehicles Act, 1988 vide Notification No. 2827(A)-WT/3M-80/2002 dated 01.09.2011 of Transport Department I, Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah do hereby issue following restriction order as per following time schedule on the following roads --

Date & Time -

On 21.07.2023 from 02:00 hrs. to 20:00 hrs.

<u>Restrictions for all type of Goods Vehicles (</u>except LPG vehicles, Vegetable, Fruits & Milk carrying vehicles)

- 1. Nimtala crossing towards Bally along GT Road.
- 2. Ballykhal Island towards Bally along GT Road.
- Bamundanga Island towards Bally & Dakshineswar along GT Road & Vivekananda Setu.
- 4. NH-2 & NH-6 Xing towards Nibedita Toll.
- Near Salap More towards Dasnagar along Howrah Amta Road on Kabardanga more.
- Kona more on NH 6 towards Liluah along Benaras Road towards Jagadishpur.
- Kazipara Crossing towards Kolkata & towards Howrah via 2nd Hooghly Bridge and GT Road.
- 8. Near Alampur More towards 2nd Hooghly Bridge along Andul Road.
- Hung Sung Crossing towards Drainage Canal Road and 2nd Hooghly Bridge.
- Kona Truck Terminal towards Kolkata & Howrah City side along Kona Express way and 2nd Hooghly Bridge.
- Near Nibra More to towards Kolkata & Howrah City along Kona Express way and 2nd Hooghly Bridge.
- 12. Howrah & GT Road bound via 2nd Hooghly Bridge & Kona Express way.

In addition to the above, no Goods Vehicles will be allowed to ply within this Commissionerate area from 02:00 hrs to 20:00 hrs. on 21.07.2023.

Restrictions for all other vehicles:

All Panchanantala bound passenger vehicles will be diverted from Sarat Statue at GR Road towards Fish Market via IC Bose Road, CM Bridge, GT Road, Phansitala, Panchanantala at Howrah.

No vehicle will ply along M.G. Road, Church Road, Nityadhan Mukherjee Road.

Restrictions of slow moving vehicles:

Slow moving vehicles will be restricted to ply along Foreshore Road, G.T. Road, Panchantala Road, N.S. Road, Grand Foreshore Road, Girish Ghosh Road, Aravindo Road, J.N. Mukherjee Road, Andul Road, Drainage Cannel Road, East West Bye Pass Road from 9 AM to 12 PM on 21.07.2023.

These regulations will remain in force in addition to the other normal traffic restrictions on the day (21.07.2023), which are not repugnant to the above.
